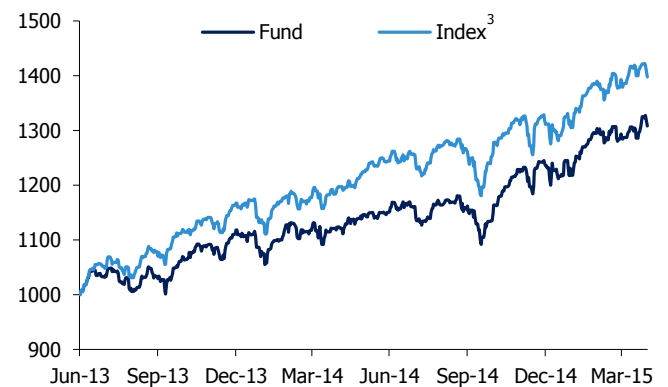

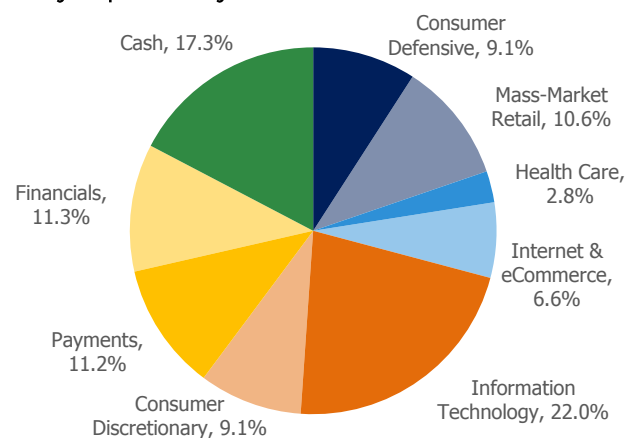
Performance Chart growth of AUD \$1,000²

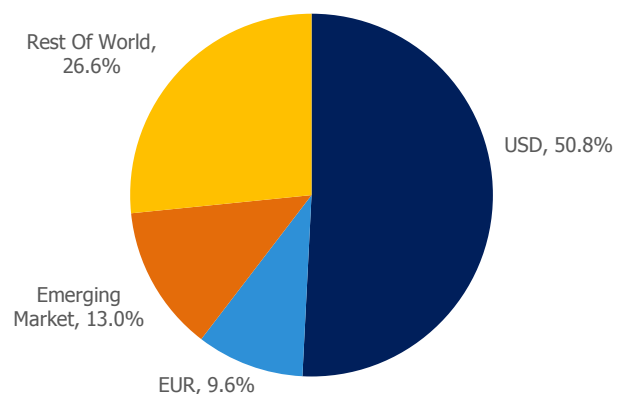
Industry Exposure by Source of Revenues⁵
