
Portfolio Commentary

During the month of November, the global market depreciated in local currency terms by -1.28%, whilst depreciation of the AUD against the US Dollar (-5.75%), Yen (-5.41%), British pound (-2.93%) and the Euro (-0.56%) resulted in a return of 0.75% for the benchmark in Australian dollar terms.


The Fund delivered 3.48% for the month and 6.98% for the quarter, outperforming the benchmark over both periods by 2.73% and 4.45% respectively. During the month, the Fund benefitted from local currency gains in Lowe's (14.22%), Home Depot (10.37%), Mastercard (7.86%), Yum! Brands (4.61%), Visa Inc (4.22%) and US Bancorp (1.29%).

Global markets remain volatile with heightened focus on the European economic and political environment influencing short term market movements. We remain confident in the quality of our investee companies and the ability of their underlying businesses to continue to perform during periods of global uncertainty.


Performance Chart Growth of \$1,000
