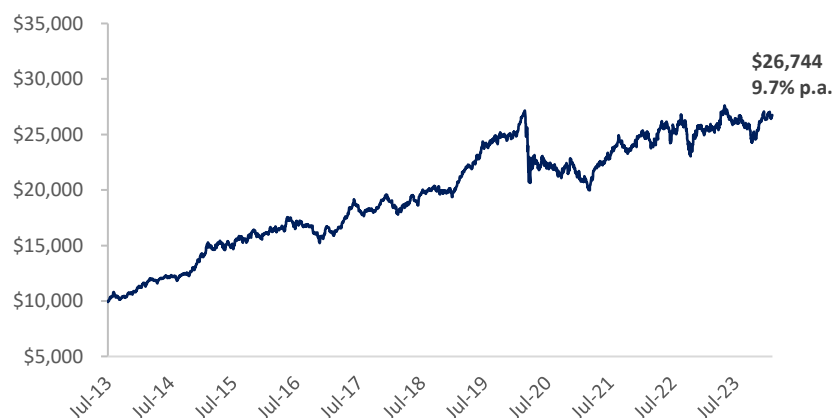

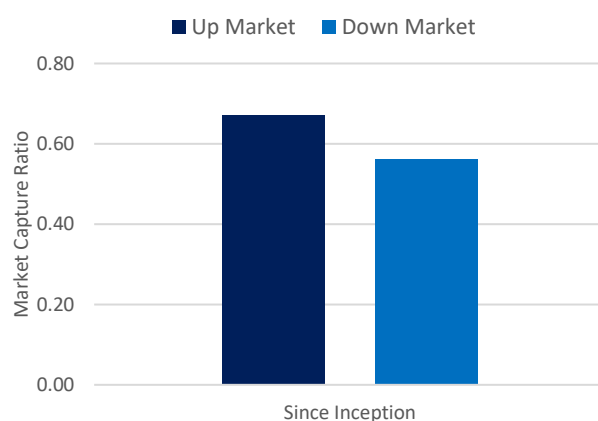

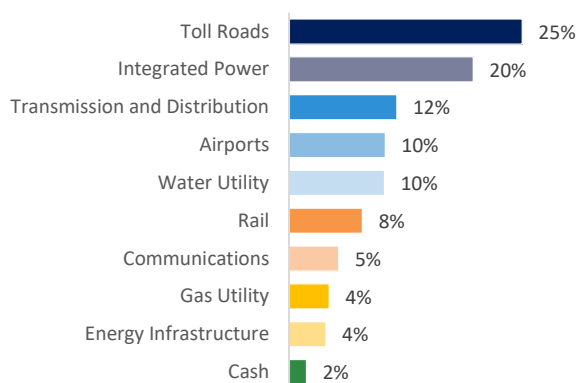

## SECTOR EXPOSURE<sup>4</sup>



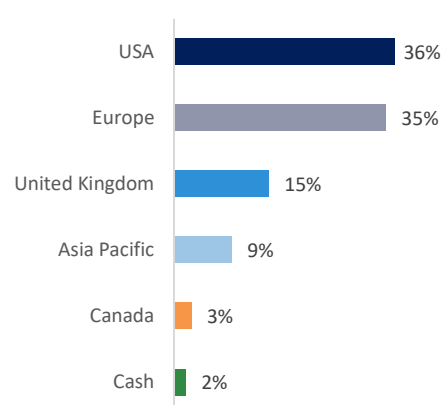

## MONTHLY SUMMARY

The portfolio recorded a positive return in January. The key contributors for the month were Ferrovial, Vinci and Groupe ADP. Spanish toll road and airport operator Ferrovial rose following the announcement of a higher-than-expected toll increase at its key 407 ETR asset. Tolls for this major asset had been frozen since the onset of the pandemic (February 2020). France-domiciled airport and toll road operator Vinci rose after reporting strong December passenger growth at several of its airports. French airport operator Groupe ADP climbed as it reported solid passenger traffic at Paris Airport and its other airport holdings.

The largest detractors over the month were American Tower, Eversource Energy and Atlas Arteria. Shares of wireless tower company American Tower fell in January on suggestions that central bankers were unlikely to lower benchmark interest rates in the near term. US-based electricity utility Eversource Energy declined as the company announced an impairment charge against its offshore wind investments. Atlas Arteria declined on rising French and US bond yields as well as protest action from French farmers, which disrupted motorway traffic.
